**Day 1: Friday, September 8, 2017 • Departure**

We depart the US late this afternoon for our transatlantic flight to Reykjavik, Iceland. This short flight will get us excited for the adventure ahead.

**Day 2: Saturday, September 9, 2017 • Welcome to Iceland**

On arrival, we transfer from Keflavik Airport to Icelandair Hotel Natura in Reykjavik where we spend the night. There will be free time to explore Iceland's capital on your own.

**Day 3: Sunday, September 10, 2017 •**

**Volcano Crater, Seals, Fjords & Mountains**

This morning we meet our tour guide and depart from the hotel. We travel west, passing the town of Borgarnes and climb the Grábrók volcano crater. In the afternoon we visit a natural history & seal museum in Hvammstangi, a small fishing village in Northwest Iceland, after the museum we stroll around the local harbour. Further north we stop at the turf church of Víðimýri which has been extensively restored to its original form and is widely considered one of the purest and most beautiful examples of traditional Icelandic architecture. We continue along scenic fjord landscape and over several mountain passes until we reach Akureyri, the capital of North Iceland. Our overnight location is at the Icelandair Hotel Akureyri. **B, D**

**Day 4: Monday, September 11, 2017 • The Capital of North Iceland, Lake Mývatn & Geothermal Baths**

In the morning we explore Akureyri, a charming town of 17,000 inhabitants. We visit the botanical garden and enjoy the panoramic

view over Eyjafjörður fjord. In the afternoon we travel to an important spot in Iceland's history, Goðafoss, the waterfalls of the gods. We continue to Lake Mývatn which is known for its geological wonders and active bird life during summer. Our next stop is the bizarre lava formations at Kálfaströnd followed by a walk around the many pseudo craters and before ending an exciting day with a relaxing soak at Mývatn Nature Baths. The baths contain a unique blend of minerals, silicates and geothermal micro-organisms – a soothing combination for skin and spirit alike. We overnight at the Hotel Reynihlið. **B, D**

**Day 5: Tuesday, September 12, 2017 • Lava Labyrinth, Hot Springs & Travel East**

In the morning we hike in a lava labyrinth at Dimmuborgir, "the dark castles", hoping to get a glimpse of the trolls who are said to live there. After lunch, on our own, we visit the hot spring area of Námaskarð with bubbling mud pools and steaming solfataras. We head through the uninhabited highlands and moonlike surrounding to East Iceland. With some luck we might spot an Arctic fox or a reindeer. We check into our hotel for overnight. **B, D**

**Day 6: Wednesday, September 13, 2017 • Fjords, Glacier and Ice**

It's a day to admire the dramatic fjord landscape and its tiny fishing villages at the end of twisty roads in the East Fjords. On route we visit an interesting stone and mineral collection. In the afternoon we see Vatnajökull – Europe's biggest glacier that is visible all over Southeast Iceland. Past the town of Höfn, we stop at Jökulsárlón, a glacial lagoon filled with floating icebergs. We explore the

extraordinary site and might even see seals swimming in the arctic waters. We can walk on the black sandy beach where large icebergs get stranded. Continuing along the southern part of the glacier Vatnajökull, we spend time at Vatnajökull National Park, Europe's largest national park, which has Iceland's highest mountains, an alpine environment, and Europe's largest glacier. We overnight at the Icelandair Hotel Kirkjubæjarklaustur. **B, D**

#### **Day 7: Thursday, September 14, 2017 • South Coast**

A beautiful drive with many natural wonders awaits us today as we head across the Eldhraun lava field. We cross the sandy desert of the south coast, overlooked by mountainous cliffs, glaciers and waterfalls and stroll along the black lava beach of Reynisfjara near Vík. In the small village of Skógar, we view the Skógafoss waterfall, which is 60 meters high and is one of the most impressive waterfalls in the country. Further west, we stop at the Eyjafjallajökull Information Center and learn about living next to a glacier and an active volcano before continuing to the high but narrow Seljalandsfoss waterfall, which plunges over the mountain. There is an interesting trail that goes behind the fall – if you are prepared to get wet! We overnight at the Icelandair Hotel Flúðir. **B, D**

#### **Day 8: Friday, September 15, 2017 • Icelandic Horses & Golden Circle**

We explore classics today, as we travel the route of the Golden Circle sights. We start the day at Friðheimar, where we learn about the Icelandic horse, its special qualities and history and pay a visit to a geothermal greenhouse. Later on, we see steam from the Geysir geothermal fields as we arrive. There are a variety of hot springs and bubbling pools. The original geyser is now dormant but has been replaced by Strokkur "the Churn" which erupts at 5-10 minute intervals. We continue to Gullfoss, "the golden falls", which is a double waterfall that tumbles 34 meters into the Hvítá river and attracts travelers all year round. Traveling inland we visit Thingvellir National Park, a UNESCO World Heritage site. As we return to Reykjavík, we take a short city tour to show highlights of the world's northernmost capital. We overnight at the Icelandair Hotel Natura. **B, D**

#### **Day 9: Saturday, September 16, 2017 • Departure Home**

We transfer to Keflavík Airport for our flight back to USA. **B**

#### **Payment Schedule:**

A deposit of \$500 per person is due with reservation. Final payment is due 100 days prior to departure date. Invoice will be sent out prior to final payment. Passengers may add after this date subject to air and land availability. Generally airlines do not increase the price of a ticket after it has been contracted. However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

#### **Currency:**

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

#### **Refund/Cancellation Policy:**

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 99 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From 99-14 days, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling less than 14 days prior to departure will receive **no refund**.
